## California Earthquake Would Accelerate Mortgage Meltdown



In light of current economic conditions, a major catastrophe such as an earthquake in California would bring new misery to both U.S. and international financiers, according to the "Annual Global Climate and Catastrophe Report: 2008," which highlights that the lack of mandatory earthquake insurance in California would result in high levels of mortgage defaults should an earthquake occur.

The largest natural catastrophe in 2008 was the tragic earthquake in China on May 12; very little insurance was in place and the rebuilding costs are estimated at \$146 billion. The largest insured loss event in 2008 was Hurricane Ike, which is likely to be the third most costly hurricane on record.

Additionally, between 1995 and 2008 there has been a signifcant increase in the average frequency and intensity of hurricanes in the Atlantic Basin.
